

**Form for consent to the use of advertising materials by customers
of ECO LIGHT Sp. z o. o.**

Company data:

1. Logos, drawings, photos and product descriptions available in materials provided by ECO LIGHT Sp. z o. o. have a promotional function. They may be placed on materials promoting ECO LIGHT brand products by the company's client, hereinafter referred to as the User. The condition for obtaining consent from ECO LIGHT Sp. z o. o. is to follow all recommendations contained in these regulations.
2. Consent to use the materials under any title cannot be transferred to another entity.
3. Company logos: ECO LIGHT, MORE, MARY'S.



a) You cannot change the shape, proportions, colors and elements of logos, as well as animate, distort or otherwise modify their appearance. In particular, it is prohibited to use or add any verbal or graphic elements to logos.

b) Logos should be placed visibly, maintaining a distance from other graphic or text elements.

4. Logos, photos, assembly and technical parameters and drawings provided by ECO LIGHT Sp. z o. o. may be placed by the User:

- a) on company cars;
- b) on materials promoting products offered by ECO LIGHT Sp. z o. o. i.e. posters, business cards, letterheads, brochures, bulletins, leaflets;
- c) during promotional events organized by the User (fairs, exhibitions, shows, conferences, seminars, training);
- d) on websites

5. Leaflets and marketing materials provided by ECO LIGHT Sp. z o. o. may be presented during promotional events organized by the User (fairs, exhibitions, shows, conferences, seminars, training).

6. ECO LIGHT Sp. z o. o. does not allow the User to copy product descriptions from websites he owns. The content presented on product cards is the intellectual property of ECO LIGHT Sp. z o. o. and are subject to legal protection. The user is obliged to edit the content of the description in order to use it on his own website. Only information such as technical and color parameters, product name or product code may remain unchanged.

7. The user of the materials provided is obliged to ensure that they are not used in a manner inconsistent with these principles and applicable law, in particular that they are not placed in publications and materials that violate or threaten to violate the personal rights of ECO LIGHT Sp. z o. o. and companies it represents, and whose content violates intellectual property rights.

8. ECO LIGHT Sp. z o. o. does not provide source files for graphic materials such as leaflets, folders, catalogs and the like. Such materials constitute the intellectual property of ECO LIGHT Sp. z o. o. and any modification thereof requires your consent. Graphic materials create a uniform and coherent image of the technical content presented by ECO LIGHT Sp. z o. o.

9. ECO LIGHT Sp. z o. o. reserves the right to control Users regarding the use of the materials provided and the right to take action against Users who do not comply with these rules and violate other rights.

10. ECO LIGHT Sp. z o. o. Users who do not comply with the rules contained in these regulations have the right to be temporarily or indefinitely deprived of the right to use advertising materials.

11. We reserve the right to make changes to these rules.
